Report about the work of Civic scientific organization «Ukrainian Assembly of doctors of sciences in public administration» in 2015 year

Modern public administration in Ukraine - is a complex, multidimensional phenomenon, that gives special urgency to the question of consolidation of efforts of aspirants, doctors, searchers, civil servants, academics and scientists with the purpose of their joining to the process of search of contemporary approaches of development of social life in the context of formation and implementation of effective activity of public administration and local government.

That is why, the solution of questions concerning of maximal preservation and enhancement of all the achievements and developments of the older generation of Ukrainian and foreign authoritative scientists in public administration, by virtue of their compliance with the global trend towards the integration of knowledge on the way of solving global challenges are acquired the great importance.

Today in Ukraine there are exist three thousand doctor of science in public administration and one hundred one thousand PhD in public administration and their association in Ukraine is an important criterion of its development with the help of which integration of all its most important resource elements, towards the achievements of socially important objectives, adequate to the changing environment, should be implemented.

With the purpose of consolidation, on a voluntary basis, leading scientists and specialists that are working in the sphere public administration with the purpose of effective use of their creative potential for scientific, technical, socio-economic and cultural development of country, for focused development of the public administration, for protection of their professional interests, for mutual coordination of research and for exchange of experience in a whole, we create Civic organization «Ukrainian Assembly of doctors of sciences in public administration» (further - Organization).

Organization was created in 2015 as a scientific, non-profit, public, political, independent entity, whose activity is carried out in directions that are not forbidden by laws and subordinate regulatory acts of Ukraine and in accordance with the statutory tasks.

Organization is represented by its separate units in 16 administrative-territorial units of Ukraine (Luhansk, Poltava, Sumy, Kherson, Kharkiv and Lutsk, Khmelnytsky, Ivano-Frankivsk, Rivne, Odessa, Lviv, Kyiv, Dnipropetrovsk, Zhytomyr, Transcarpathian region and c. Kyiv). In December Organization confirmed the status of the All-Ukrainian organization.

Organization registered in the Ministry of Justice of Ukraine, in established by the legislation order, its own symbolism.

In order to provide a clear and productive basis for working together, Organization has concluded a number of cooperation agreements with such partners as: Interregional Academy of Personnel Management, Academy of Municipal Administration, National Academy for public administration under the President of Ukraine, Kherson Technical National University, National Service of Mediation and Reconciliation, Supreme administrative court of Ukraine, Mukachevo district state administration of Zakarpattia region, The Association of Aid and Assistance to the Economic Initiatives, Khmelnytsky University of Management and Law, State Property Fund of Ukraine, Solomianka district in Kyiv state administration, Poliske district state administration of Kyiv region, National Independent Trade Union of Transport Workers, School of higher education "National

Academy of Management", Confederation of private schools of higher education, O.M. Beketov National University of Urban Economic, Sloviansk City Council, NISPAcee, TAIEX, Global Development Network. In cooperation, conduction of general-Ukrainian, regional, inetrnational industry conferences, symposia and workshops, directed on solving of the state-management problems in different sectors of society, are scheduled.

Thus, Organization promotes to the development and reproduction of intellectual potential of society, to the dissemination of scientific and technical achievements in the field of public administration and to the fullest use of science's achievements in the interests of socio-economic development of Ukraine, in general.

Organization, together with the Interregional Academy of Personnel Management, is a co-founder of scientific journal «Public management» and received Certificate On making publishing entity in the state register of publishers, manufacturers and distributors of publishing products (received International standard numbers of books ISBN, which provide the opportunity to publish scientific monographs, textbooks and books). The editorial board is formed with representatives of separate section, due to the professional direction of each scientist, that facilitate esteemed readers and potential authors the process of application to members of the editorial board with the questions, and suggestions to materials about scientific cooperation. comments The editorial board includes 55 doctors of science from Ukraine, Poland, Georgia and Bolharyiyi. Languages are: Ukrainian, Russian and English.

In November 2015 the first issue of collection «Public management» was printed. The International Standard Serial Number ISSN 2414-0562 is assigned to the collection. Work on includining collection to the leading scientometric databases is conducted.

Organization started and successfully completed the following main projects and activities since the beginning of its existence:

executive secretariat responsible for the implementation of all Organizations functions and programs was established and further developed;

scientific journal «Public Governance»;

launched publication programmes for information, teaching as well as research purposes including proceedings from conferences, summer workshops and other events;

data base, which consist of three thousand of doctor of science in public administration and one hundred one thousand PhD in public administration:

projects as:

- 1. «My civic consciousness from the questions of prevention, combating of the corruption and crime in Ukraine» (further Project). The purpose of the Project is reducing of the level of corruption in Ukraine by the way of addressing the conditions of its emergence through providing of the proper level of knowledge of anti-corruption legislation as for the government representatives, local authorities, and for the society as a whole and as a result, formation in the community intolerance, negative attitude to corruption as socially dangerous phenomenon.
- 2. «Civil society and legal state: dialog and partnership» (further Project). The Project objective is to build up dialog with public authorities socially determined by citizens' needs and wants by way of comprehensive analysis of the theoretical-methodological and practical and application-oriented principles of their operation and developing recommendations as to their organizational and legal improvement. In its

turn, this will facilitate comprehension and interpretation of the problem of legitimacy within Ukrainian society, study of the specifics of interaction between authorities and the population during independent development of Ukraine and identification of the core principles for designing a new format of dialog between the state and society at the present stage.

3. «Resource Center for public service and service in local government» (further - Project). The purpose of the Project is realization of mechanisms of professional, civil self-regulation for the process of development and improvement of training and retraining of civil servants and identification opportunities and prospects of their use in Ukraine.

President of Organization Yevhen Aleksandrovych Romanenko signed in the Scientific Advisory Board of the Supreme Administrative Court of Ukraine and in the Scientific Advisory Board of the State Architectural and Construction Inspectorate of Ukraine.

Informational-consultation Center of the National Service of Mediation and Reconciliation in Kyiv and Kyiv region is created on the base of Dept. Public Administration AIDP, headed by Y. Romanenko.

Organization held, together with the Academy of Sciences of Higher Education of Ukraine, the National Union of Journalists of Ukraine, the Institute of Journalism at Kyiv National Taras Shevchenko University, Graduate School of International Relations and Public Communications in. Helm, Pomeranian Academy in. Slupsk, International Organization of Journalists «4 power» in. Helm, two conferences:

- 1. International scientific-practical conference «Modern social communication: challenges, priorities and priorities in the European integration process», held ing November 27, 2015 in Helm, Poland.
- 2. V international scientific-practical conference «Information space. Ukrainian reality: Experience Transformation», held in November 28, 2015 in Helm, Poland.

During the conferences were held plenary and breakout sessions that were held at a high scientific and theoretical levels. Selected conference topics were the basis for fruitful exchange of views from the depicted problematic. According to the results of the conference were published collections of papers: «Information Space. In September 2015 President of Organization, Doctor of Science in Public Administration Y. Romanenko, by the competition, was elected academician of Ukrainian Technological Academy in the department of social and humanitarian technologies.

Organization. Kyiv) and X International scientific conference «Study and implementation in Ukraine of foreign experience improvement of government (November 25, 2015, c. Poltava).

Organization, together with the Regional Academy of Management (Kazakhstan), the European Science Foundation «Institute for Innovation» (Poland), Regional Centre for European Innovation (Poland), the National Institute of Economic Research (Georgia), East European Institute (RUSSIA Federation) University of Economics and business (Kazakhstan) and Tarazskym innovative humanitarian University (Kazakhstan), was a cofounder of the International scientific conference «innovative management and technology in the era of globalization», held in the United Arab Emirates (12-14 January 2015, c. Sharjah).
